Director of Coaching/Program Director – Pete Cinalli

Mr. Cinalli made the following announcements:

- The club will host a USSF D license course at Hotspur Park June 2006.
- Due to Memorial Day and Sand Soccer tournaments as well as late league games into June 2006 tryouts will probably occur in middle of May and June.
- New lease agreement was not approved by Elks Lodge
 - Present lease is good until 2009
 - Elks Lodge can give club a 1 year notice that lease will be terminated.
 - Club is considering purchase of 30 acres on Route 632/Route 608 Massaponax Church Road, Spotsylvania County.
 - Owner will to finance purchase price of \$600,000 at 5% interest.
 - Estimate cost of \$50K per field – 4 large & 4 small.
 - Topographic maps need to done.
 - Permits/fees/retainers/plans/etc need to be discussed.
 - Meeting with Board of Supervisors will be required.
 - Need to find corporations interested in investing in fields/club.
 - Fees will probably go up if we purchase new fields.
 - Tournament and Recreational League growth could offset some cost associated with purchase of new fields.
- Construction tape will be placed around pond at Elks Lodge instead of purchase of fencing.

- Top Soccer will be held at Chancellor Elementary Friday evenings 5:30-6:30pm.
 - Top Soccer buddies needed – buddies will get community service hours for participating in program.
- Director of Elementary Education has been appointed to oversee clubs scholarship program.
 - An additional \$500.00 has been given towards an additional female scholarship which means (1) \$500.00 scholarship for 1 male athletic and (2) \$500.00 scholarships for female athletics.
- Cosmo uniforms through Adidas only have 3 year lifecycles. Club will need to consider purchase of new uniforms in the next year and a half.
- Consider changing vendor from Eurosport to Gamers for the purchase of Adidas wear, etc.
- Ms. Julie A. McKeen was introduced by Pete as the Editor/Publisher of the Hotspur News.
 - Spring 2006 was the first edition.
 - Might focus on an individual team for each edition
 - Might focus on team accomplishments/successes each edition
