

Fredericksburg Area Soccer Association (FASA) Hotspurs Meeting

Minutes for the June 19, 2006 club meeting. The meeting was held at Cosner Park Community Center, Fredericksburg, Virginia.

President – Wayne Zimmerman

The following announcements were made by Mr. Zimmerman:

- Position is open for the club Fundraising Director.
- Mandatory fundraiser is scheduled for fall 2006.
- Each player will be required to sell or buyout \$50.00
- If a player leaves the team the money raised by that player stays with the team.
- If a team leaves the club the money raised by the team stays with the club.
- The Harrison Road practice fields are scheduled to open around August 1, 2006.
- Every team within the club will get at least 1-2 practice sessions under the lights at Lorella Park this fall 2006.
- Next meeting will hold lottery for practice fields.
- Reminded teams to be aware of non-sanctioned tournaments. Teams that participate in tournaments that are not sanctioned by VYSA are not covered by insurance.
- If teams participate in out of state tournaments consider participating in tournament sanctioned by that states youth soccer association.
- Received letter from Elks Lodge concerning playground equipment continuing to be used against the club and lodge agreement. Please remember to tell your parents and opposing teams that playground equipment at the Elks Lodge is off-limits to all children. (Please do not use the lodge even if you are a member while your child is in a club uniform.)
- Remind parents and opposing teams to park in designated parking areas at Elks Lodge.
- Continuing to pursue the purchase of land for club fields. There are 29 acres on Massoponax Church Road, Spotsylvania, VA that the club might be interested in purchasing.
- He continues to pursue all avenues of obtaining property for the club.

Director of Coaching/Program Director – Pete Cinalli

Mr. Cinalli opened the meeting at 7:00pm. Mr. Cinalli turned the meeting over to Ms. Mary Smith who explained the purpose of the binders being passed out to the managers of the new teams.

- Binders were generated to provide examples of team rosters, medical release & permission to travel forms, bank and coach information as well as answer various questions new team managers to the club might have. Ms. Smith provided her telephone number and web site should new managers need additional information.

- Club tryouts went well. The club spent a few thousand in advertising tryouts in the local paper.
- About 41-42 teams are presently with the club.
- Practice field web page will be updated by Gordie.
- New Adidas uniform order forms are available on website in Excel and PDF version.
- Spotsylvania P&R pulled goals, seeded and fertilized fields at the Harrison Road practice field.
- New position as the Classic League Director will be created within the club. This position will be responsible for the following:
 - Promotion of the ASDL program
 - Registration of players
 - Parent meeting
 - Fee collection
 - Schedule practices, games and referees
 - Handle administrative issues
 - Update rules and bylaws as needed
 - Various other duties as required.

A motion was made and voted on this date to create the Classic League Director position within the club.

Gamer Sports – Billy Oehm

Mr. Oehm is the owner of Gamer Sports Shop located in Fredericksburg, VA. Gamer Sports was voted by the club members last month to replace Eurosport as the clubs provider of club uniforms, etc. Gamers Sports Shop is located at 11105 Leavells Road #10 &11, Fredericksburg, VA 22407. Mr. Oehm made the following announcements:

- Gamers is stocking 300 uniform sets to include both new and old uniforms.
- Bring players in for sizing is necessary.
- Adidas adult small is usually a man's small.
- If uniforms are needed for fall 2006 season the earlier he receives the order the better.
- Orders should be to him NLT July 1, 2006.
- Turn around time with lettering is usually 3 weeks.

- He offers discounts to club members. Team members who purchase items from Gamers need to tell store personal they belong to FASA to receive a 20% discount.
- Discount does not apply to uniforms or items on FASA Uniform Order form as these items have already been discounted.
- Items which can be purchased with a discount are balls, shoes, shinguards, sweatshirts, etc.
- Embroidery and silkscreen is done by Gamers.
- Club cannot be billed for orders placed.
- FASA Uniform order form is available on club website.
- Can do individual orders for teams like the Spiders as long as he receives the team logo.
- Plans to carry Hotspur logo items like water bottles, hoodies, sweatshirts, etc.
- Place order and pay on pickup.
